

The Tanzania National Roads Agency (TANROADS), is a Semi-Autonomous Agency in the Ministry of Works and Transport established on 1st July, 2000. It is responsible for day to day management of the Tanzania mainland's Trunk and Regional Roads Network as well as construction of Airports.

The Tanzania National Roads Agency (TANROADS) on behalf of the Government of the United Republic of Tanzania has entered into a Contract for the Upgrading of Ntyuka Jet. – Mvumi – Kikombo Jet. - To undertake laboratory apparatus and calibration of equipment;
- To prepare materials testing reports; and
- To perform such other related duties as may be assigned by the Materials Engineer
